If you have a tax liability for 2015 or owe any of the following taxes for 2015, you must file Form 540 . • Tax on a lump-sum distribution . • Tax on a qualified retirement plan including an Individual Retirement Arrangement (IRA) or an Archer Medical Savings Account (MSA) . • Tax for children under age 19 or student

under age 24 who have investment income greater than \$2,100 (see paragraph above) .

Sales & Use Tax in California. The use tax generally applies to the storage, use, or other consumption in California of goods purchased from retailers in transactions not subject to the sales tax. Use tax may also apply to purchases shipped to a California consumer from another state, including purchases made by mail order, telephone, or Internet.
